

PUBLIC NOTICE

As provided by Chapter 197 Acts of 1974, notice is given that tangible personal property taxes assessed for the year 2025 are now delinquent and beginning April 1st, such taxes are drawing interest at 18 percent per year plus the proportionate cost of publishing this notice and delinquent cost.
