Papa Johns, new apartments coming to Starke

Papa Johns could be the next restaurant to open in Starke.

The selected location is Commercial Drive next to Jackson Hewitt Tax Service, right in front of Walmart. Starke's building and zoning office is awaiting plans to bring the space up to code to support a commercial kitchen.

According to its investor relations website, Papa Johns has headquarters in Atlanta, Georgia, and Louisville, Kentucky. It is the world's third-largest pizza delivery company with more than 6,000 restaurants in approximately 50 countries and territories. The company has been around since 1984.

Papa Johns' marketing has always been "Better ingredients. Better pizza." Presumably the same is true of its other offerings, which include its signature papadials, papa bites and papa bowls, along with its wings, sides and deserts.

The Starke location is already

searchable on its website, showing carryout and delivery options will be available.

New housing opening up

Lance Campbell in Starke's zoning office said Sandcastle Pines has just received its certificate of occupancy. This is the rental housing development of 22 homes constructed at the end of North Westmoreland Street. It was funded through the Florida Housing Finance Corporation.

Anyone interested can apply online at www.sandcastlepines.com. The minimum household size for these four-bedroom, two-bath homes is three members. All household members over the age of 18 must submit a separate application, and there is a nonrefundable \$50 application fee for each. Minimum income level is \$1,950 a month.

Apartments coming, too?

Two recent environmental resource permit applications submitted to the Suwannee River Water Management District involve housing developments in Starke.

One is for New River Place, a new apartment complex proposed on Thomas Street. According to Invictus Development's website, the 80-unit development was funded by the Florida Housing Finance Corporation with Live Local funds in April. With one to three bedrooms, the apartments were pitched as housing for active military members from Camp Blanding Joint Training Center.

Campbell said the site plan shows three apartment buildings and a conference center. A much larger housing project with 234 apartments known as Strawberry Fields was denied a land use change in 2009 because the city commission did not want more subsidized housing.

According to Invictus, pending the necessary permits, construction should begin in the third quarter of 2025, with apartments available to rent in late 2026 or early 2027.

The other housing project applying for permitting is CityWalk townhomes on East Call Street, next to the Downtown Square. Once constructed, the 45 townhomes will be ready for rent or purchase, with a rent-to-own option available to its target residents, which includes teachers, nurses, first responders, correctional officers, and active and retired military.

The two-story units with three bedrooms and two bathrooms will be sustainably designed and constructed, incorporating high tech and green technology, including solar power. Unlike the other housing projects, CityWalk is not subsidized with government funding.

The developers are Dwight Hewett and Jason Doran of Kingsley Development and The Doran Jason Group.

'These people need help' Van Zant leaves KH city hall for next mission

Three weeks ago, Charlie Van Zant was walking his dog at an Interstate 10 rest area when he got a call from an old acquaintance from Tallahassee.

The Keystone Heights city manager and his wife, Stephanie, were on their way to Eglin Air Force Base to visit their son.

The call was from Anthony Sabatini, whom Van Zant knew from Sabatini's days as a state house member. Weeks earlier, the Lake County-based Attorney had hired former Keystone Heights city Council member Gavin Rollins for his staff.

In May, the City of Treasure Island

hired Sabatini's firm to handle its legal affairs, and in making the call to Van Zant, Sabatini was helping in his client's urgent search for a city manager.

Treasure Island terminated its city manager in June, following allegations that he mishandled storm recovery efforts from Hurricanes Debbie, Helene, and Milton.

Rollins recommended that Sabatini call Van Zant, and after the retired Army helicopter pilot answered the phone in the I-10 rest area, Sabatini put Treasure Island City Commissioner Chris Clark on the line, who got right to the point.

New elementary school's funding approved

The first of three years of funding for a new Lake Butler Elementary School survived Gov. Ron DeSantis's veto pen on June 30, clearing the way for the state to fund one-third of the \$88.5 million project in the upcoming fiscal year.


Last September, Superintendent Mike Ripplinger successfully lobbied the Florida Department of Education's Special Facility Construction Committee to rank the school as the state's top school construction project.

The superintendent said \$64.6 million would fund the construction of a new pre-k through fifth-grade school, \$19.6 million would provide money to demolish and renovate the current school for other uses, \$2.2 million would renovate the middle school gym, and \$2.1 million would finance moving the district's administrative offices to the current elementary school campus.

In his presentation to the Special Facility Construction Committee, Ripplinger said the elementary

school's buildings date back to 1956, and the school's 22 portables have outlived their life expectancies. He also said the current campus is overcrowded, the large number of drop-offs and pick-ups causes traffic issues, and the district is spending an inordinate amount of money to maintain the aging facilities.

The superintendent added that the new school would allow the district to move fifth-grade students from the middle school to the elementary, eliminating the need for three portables at the middle school and converting the sixth through eighth-grade campus into a fully brick-and-mortar schools.



District officials hope to purchase a 23.23-acre pecan grove and hay field owned by Shadd Properties, LLC, for the new school's site. The parcel across Southwest 6th Street (State Road 121) from the Lake Butler Apartments is adjacent to the current campus.

Student test scores point to progress

According to school administrators, performance on the Florida Assessment of Student Thinking and other state standardized testing is pointing to significant improvements in Bradford schools.

With several weeks until school grades are revealed, Superintendent Will Hartley is confident this will be the school district's highest charting year.

More than tracking English and math performance by grade

from year to year, the FAST test is administered three times per year, allowing student performance to be measured throughout the school year. Proficiency is tested at the beginning, middle and end of year. Grades three through 10 are tested in English language arts, and grades three through eight in math.

"I think it's extremely helpful, and we've gotten really good at using that data to drive our instruction," Hartley said. It's impossible to predict results on the first assessments taken in August and September. Tests at

each grade level vary greatly, and students are tested on standards they've never seen before. Even still, a handful manage to score Level 4 or 5, which is considered proficient or exemplary. Typically, the first test shows most students scoring below Level 3, which is below grade level.

"The one that I think is most helpful is PM2 at Christmas, because it gives you a good gage of what you've done in those few

months from August until then. But it really, really drives what we do after that," Hartley said. So helpful is this way of doing things that the district has started developing mid-year exams that mirror the FAST tests for subjects that are not tested until the end of the year, such as algebra, geometry, biology and history.

"At first I thought that it was going to be too much, but I also think that the kids seeing it three times, I think they get a different comfort level with it, too, and

there's not so much anxiety on that last test, because they know what's coming," he said. Standout results include third grade English where 68% of students scored at or above grade level, which was 16 percentage points higher than last year and 11 more than the state average. There were sizable jumps in other grades as well, such as 16 percentage points in the seventh grade, and sixth grade's performance also topped the state average. And with 51% at 55% at or above grade level, the ninth and 10th grade English scores have never been higher. The only grade that couldn't claim improvement in English or

math was the fourth grade. While there wasn't as much improvement in math, the two standouts were third grade which grew by 7 percentage points and sixth grade, which was 12 percentage points above last year. Lawtey Elementary School had the highest English performance in the fifth and sixth grades, and its fourth graders tied with Brooker Community School. Brooker third graders were top in English with 90% at or above grade level by year's end. They were lowest in third and fourth grade math, however. Again, the highest percentages in math for grades three through sixth were at Lawtey.

Fifth and eighth graders are also tested at the end of the year in science. Overall, 58% of fifth graders districtwide scored at or above grade level, which was higher than the state average. Lawtey had the highest result at 69%. Eighth graders at Bradford Middle School were at 39%.

As for the end-of-course exams, BMS tied the state average with 60% at or above grade level in algebra. The Bradford High School percentage was 44%. BHS's geometry result was 61% which was 6 percentage points higher than the state average. Biology results were 64% at or above grade level, 53% for civics and 46% for U.S. history.

The scores from the Department of Education website include the results of all students tested, but Hartley explained all those students will not be included in school grade calculations. Only results from students present for the second and third student counts are used to calculate school grades. When the other scores are eliminated, several categories show higher overall scores, which, according to Hartley, should help boost school grades. He mentioned sixth grade math as well as geometry and biology.

BHS Principal Chris Coffey has already highlighted performance in these and other categories. On three end-of-course exams, biology, algebra 1 and geometry, the scores were the highest in school history and they had some of the highest growth rates in the state — third in the state for algebra and second for geometry. The ninth and 10th grade English scores

we're also the best in the school's history, according to Coffey. While awaiting the annual report card, Hartley said the district is using data from this past year's testing to amend its subject pacing guides. They are looking at successes in other districts and investigating what is working for them. The superintendent said other districts are seeing Bradford's achievements and reaching out for advice as well. He said collaboration is leading to growth everywhere.

Fire assessment moves forward to August hearing

Impact fees advertised now

Without question or comment from the public or commissioners, the Bradford County Commission approved a resolution Tuesday proposing the amounts for its fire assessment fee.

After years of debate, there may be little left to say, although the resolution also sets the date of the final public hearing and vote — Aug. 21 at 6:30 p.m. Before then, every impacted property owner will be notified by mail of the hearing and the amount they will be assessed.

For each residential dwelling

unit, the proposed assessment is \$167. Nonresidential, primarily commercial, properties would be assessed at 11 cents per square foot. Owners of vacant parcels would pay \$46.50 per parcel. Like the solid waste special assessment, the fire assessment will appear on property tax bills and be paid annually. The fees may be increased from year to year, but by no more than 4%.

Churches and nonprofits would be exempt from paying the assessment, as would fully disabled veterans and those living at or below the poverty threshold. Property owners would need to apply for those exemptions. There will also be a process for disputing the amount charged if property owners believe there has been an error.

Revenue from the assessment is estimated to raise around \$1.68 million, approximately 50% of the fire department's budget. Starke has its own fire department and has opted out of participating. Property owners in the remaining cities will be charged if the final resolution is approved in August.

Impact fees

Before the final vote on the fire assessment, county commissioners will vote on whether to bring back impact fees.

Impact fees are paid on new construction at the time a building permit is issued, and the revenue is restricted to paying for new costs that are the consequence of growth. The county had impact fees in place until the 2008 housing market crash, which led to a moratorium.

Although the fees have been discussed, there has been no action taken to replace the old fees until now, with commissioners

realizing the revenue they've missed from housing and commercial development in recent years.

While past impact fees covered a few areas, these are focused on creating revenue for fire protection, law enforcement and emergency medical services.

The residential fees proposed are \$498 per dwelling unit for fire protection, \$304 for law enforcement and \$258 for emergency medical services, for a total of \$1,060 per new dwelling unit.

The nonresidential fees proposed are \$194 per 1,000 square feet for fire protection, \$119 for law enforcement and \$101 for emergency medical services, for a total of \$404 per 1,000 square feet of new nonresidential construction.

An additional 2% would be charged to cover the cost of administration and collection.

The ordinance will be presented at the July 17 county commission meeting, which begins at 6:30 p.m.

When disaster strikes, Clay County's Amateur Radio Club answers the call

Starke City
Commissioner helps
lead group

On Saturday, June 28, Camp Chowenwaw Park in Clay County hosted the ARRL Field Day. The event lasted for 24 hours as amateur radio operators gathered to achieve essential goals and test their equipment in preparation for potential disasters, such as the upcoming hurricane season or an electromagnetic pulse (EMP) event.

In 1973, the ARRL Field Day was established, and the Orange Park Amateur Radio Club was founded during this time as well. Each year, the club promotes this event as part of its participation point system.

The club holds an annual field day that coincides with the start of hurricane season. During this event, members test their radio equipment to ensure they are prepared for any emergencies that may arise during the season. It is essential to understand how quickly communication methods can be restored for

first responders in the event of a storm disrupting traditional communication lines.

"For the event, we come out and set up our equipment as if we were setting up for a disaster. Then we work for 24 hours straight, trying to make as many contacts as possible throughout the United States and the rest of the world. We ensure our equipment is functioning and ready to go for the needed hurricane season," said Scott Roberts, who is a Starke City Commissioner and the Assistant Emergency Coordinator for Clay County Amateur Radio Emergency Service.

At the event, they set up a specific satellite antenna that is used to communicate with all the satellites. Even when the International Space Station passes by, they can communicate with it.

The field day consists of three parts:

1. Analog, also referred to as single-sideband and voice communications.

2. CW, which stands for Continuous Wave, is a form of Morse code; today, it is often transmitted using a computer.

3. Digital mode, which

allows communication with other stations. In this mode, the computer can detect signals in the noise that are beyond the range of human hearing.

"I am here at Field Day to also set the network up and to assist other operators in getting their stations up and running and to educate not only other amateur radio operators who are out here for their very first time. But any members of the public who happened to wander through and have never been exposed to amateur radio. In today's digital age, even cell phones are still relevant, as the older types of communications, such as shortwave, remain relevant in the world. Whether it be for communications or scientific principles," said Charles Helverson, field day chairman and treasurer for the Orange Park Amateur Radio Club.

"Now is the perfect time to get your amateur radio license. There's a lot of interest in it, and we would love for them to come out and contact us," said Roberts.

to hire Van Zant on an interim basis, and the mayor extended a job offer to him.

Van Zant responded by taking Stephanie on a weekend trip to Pinellas County to explore the area.

"There are beautiful beaches," he recalled of the trip. "Beautiful hotels and condos that weren't damaged, and there are pieces of it that reminded me of Kuwait after Saddam rolled through there with his T-55 tanks in 1990, steel rebar hanging out of concrete."

Van Zant said that as he and his family prayed over the impending decision, one message kept coming back to his mind: "These people need help."

"As Stephanie and I were sitting on a piece of concrete on city property," Van Zant recalled, "watching the sun go down that Sunday night, I told my wife, 'They've got engineers, they've got all the professionals, but they're in drastic, dire need of leadership. They just need somebody to put the puzzle back

together.'"

Van Zant later received a call from a federal official who described the dysfunction at Treasure Island's city hall as the town tried to recover from the three storms.

"We sent them resources, and we could never get a reply back from the city, so we redeployed the resources somewhere else," said the official, according to Van Zant.

Charlie Van Zant's last day at the Keystone Heights City Hall is July 15.

As a retired career Army officer, he sees his series of jobs as missions, and he and his family concluded that it was time for the next mission.

"I'm not disparaging anybody," Van Zant continued, "but the problem with being Christian and praying about things is sometimes when you just clearly hear the call for the next mission, then you actually have to do it, or risk being disobedient. I don't know how else to say it."


He served for 27 years as an engineer in the Army with three combat deployments in Iraq and one in Afghanistan. He told council members he has had as many as 400 soldiers under his command.

Punched, kicked, threatened, spat at deputies

Tanisha Barnwell, 21, of Lake Butler, was arrested by Union deputies on June 25 for battery on a law-enforcement officer and making death threats to a law enforcement officer.

According to an arrest report, the defendant's mother called 911, telling a dispatcher Barnwell was "having a mental episode, punching holes in the wall." The caller also warned the dispatcher that the defendant had a collection of knives in her room.

When deputies arrived at the home, the mother told Deputy James Jankowski that Barnwell had been off her medications and had been stabbing holes in the walls as well as punching them.

"At this time," wrote Deputy D. Sumner in the report, "(the mother) got Tanisha to open the door to her bedroom. Once Tanisha opened the door, she advised she punched the holes in the wall. Tanisha was speaking as if she was having a mental episode."

The defendant then began to retreat into the bedroom and attempted to shut the door. Sumner reported that Jankowski placed his foot in

the doorway to keep Barnwell from closing the door and retrieving a weapon.

"At this time," Sumner wrote, "Sgt. Jankowski attempted to grab Tanisha and place her in custody under the Baker Act."

Barnwell reacted by pulling away and retreating to the back of the room.

"Sgt. Jankowski and myself immediately rushed Tanisha and went hands-on with her to keep her from retrieving any weapons," Sumner

wrote. The deputy claimed Barnwell punched Jankowski in the chest several times.

"Tanisha also struck me several times in the chest area, causing equipment on my vest to break and fall off," Sumner added. "While attempting to gain control of Tanisha's hands, she was also kicking us. Tanisha struck me several times in the legs with her legs."

The deputy wrote that during the fight, Barnwell made several verbal threats to kill the officers. He also said that when he was handcuffing the defendant, she grabbed his hands and arms in an attempt to scratch him, and from the back seat of his patrol car, the defendant spat at him, hitting a partition between the front and back seats.

Ripplinger showed committee members photographs of damage caused by compromised roofs, standing water caused by inadequate drainage, and an undersized cafeteria that can only serve one grade at a time, lengthening the time it takes to serve students lunch to nearly two and a half hours.

Will be one of the largest K-5 schools in Florida

Ripplinger said that once fifth-grade students move to the new

elementary school, the campus will host nearly 1,200 students.

"It will be a very large school," he said. "You're not going to find very many elementary schools in the State of Florida with a thousand students or more."

According to Niche.com, the largest K-5 schools in Florida are the City of Pembroke Pines Charter School, with 1,898 students, Mater Academy Elementary in Miami, with 1,529, and Horizons Elementary in Davenport, between Orlando and Tampa, with 1,468 students.

The superintendent said the district could split the elementary school population, sending some students back to the old campus after renovations. However, that option would tamper with what

Ripplinger and many in Union County feel is a cherished feature of the local school district: one elementary, one middle school, and one high school, which connects students emotionally with one shared experience and strengthens the community.

"It's not the norm," the superintendent said of the large student population, "but we believe it's important to continue that common experience that (Union County students) share. Everybody's a Tiger; we're all purple and gold, and we move you together, all the way through your graduation year."


Hickman Dye III




Pat Henry





Melrose increased its lead to 5-0 in the third. Juan Oquendo singled, advanced to third on an error and scored on a Trull single. Trull scored on an error.

Currington reached on a ground-ball error to lead off the bottom of the fourth. Carter hit an RBI single and then scored himself on an error. Frazier and Branson Byrd both walked and then scored on a Trull single, making the score 9-0.

Conner Flinchum was hit by a pitch with the bases loaded in the fifth, scoring the final run.

Trull finished 2 for 3 with three RBI, while Carter went 2 for 2 with two RBI.

Melrose got three RBI each from Oquendo and Trent Peacock in defeating Hamilton County 14-4 on June 28.




