Deal makes one-third of Union County off limits to development

The head of Union County's Economic Development is sounding the alarm over a recent land deal between Weyerhaeuser and the state, which he said could hinder the county's future industrial growth.

Bob Cotgreave said a series of sales and conservation easements would shut off the northern one-third of Union County to business development.

The deal, setting aside 78,000 acres completes the Ocala-to-Osceola Wildlife Corridor.

County Coordinator Jimmy Williams added that he was eyeing the northern part of the county for future industrial zoning, far from the county's primary residential areas, and close to the Tri-County landfill in Raiford.

Williams said he envisioned warehouses or manufacturing facilities near the landfill, with easy access to Interstate 10 and other developments in Baker County.

"There are a lot of things that can work together out there in an industrial area in that mindset on State Road 229 north just before the Baker County line," he told county commissioners on July 7. "You're just moments from I-10 also, and that's just forest land, which would be ideal for a 50-acre fenced-in area, maybe making computer chips or something, or warehousing, or something like that, for growth of jobs in the county, and revenue sources. This corridor has taken that off the table at this time as far as we know."

Cotgreave said that future conservation easements could set aside land as far south as Butler Lake.

Williams told commissioners that in his view, the best way to approach the issue is in coordination with other counties and with the state's small counties coalition.

Williams and Cotgreave said their biggest complaint is that state officials did not consult with the impacted counties before striking the deal, neglecting to consider the economic impact of setting aside such large parcels of real estate.

Williams told commissioners he has already talked to Bradford County officials about the issue and will bring it up with other county officials soon.



Public housing official: 'We're not the projects'

An official with the Union County Housing Authority attacked some of the stereotypes surrounding public housing and homelessness during the June meeting of the Union County Impact Initiative.

Amanda Ford said that a common image of public housing is that of a filthy, crime-ridden high rise.

"We're trying to get away from the whole mentality of it's the projects," she said. "It's housing. It's a home for people."

Ford said homelessness is misunderstood by the general public.

"If you've ever been in places like Atlanta, Jacksonville, Gainesville, or Lake City, you see the general definition of homelessness," she said. "You see people living under the bridges or they're living on the streets, but homelessness actually means more than that. Homelessness means that they don't have a permanent residence."

Ford said the Union County School District has identified dozens of homeless students.

"In our office, we see 200 people that come through our doors each year and state that they're homeless or they're living in their cars."

Ford said there is a significant unseen homeless population in Union County that needs help.

She also said that pending legislation in Washington could worsen the county's homeless situation by cutting benefits to people who need them most.

"it could be you," she told the crowd. "You could lose your job, you could face the sickness or something that is going to just make you lose your job. Where are you going to live?"

Ford asked audience members to jettison the myths surrounding public housing and contact their legislators to stop new laws that would reduce federal housing programs.

Bradford agrees to fund joint youth recreation program

Bradford County commissioners came to a consensus to approve funding for a new youth sports recreation program last week.

The program will finally unite the county with the city of Starke as partners in recreation along with the Tourist Development Council. Each board is contributing \$150,000 to the rec budget.

County Chairman Danny Riddick began discussion during the county budget workshop asking for the same understanding shown to the fair board. A recreation program could become self-supporting, but it would take some upfront investment from the county. If

that doesn't happen within two years, they can eliminate the program, he said.

The city and TDC boards had already agreed on financial support, he said. Commissioners were looking for a way to commit funds that didn't require further spending from their reserves.

Riddick said he knows money is tight and if the state eliminates property taxes, drastic cuts would be needed.

"I'm not putting that off, but at the same time, I'm not going to live in fear and not doing something for our children just because of a what-if," he said. "The bottom line is, do we want to take a chance for two years to see if it will become self-sustaining and to help our children?"

Commissioner Chris Dougherty didn't want to compare recreation to the fairgrounds, which the county already invested \$1.7 million to acquire. That money was spent out of the general fund reserves to save the fairgrounds from foreclosure, and that is where their commitment should be, he said.

But Dougherty mentioned another way to raise tourism revenue. Seminole County has approved a Tourism Improvement District. Hotels with 60 or more rooms have added a \$1.75 charge to their bills to fund improvements that will increase tourism, which benefits the hotels. Like the TDC board, a TID board helps govern use of funding. In Seminole, they will

build an indoor sports complex.

Dougherty cautioned against spending money from reserves on recurring expenses, especially considering the discussions in Tallahassee over property taxes.

"I understand what you're saying about what-if, but this thing's growing legs really fast it is. I mean, it's coming hard. People like the narrative. People like to think that they wouldn't have to pay property taxes," he said.

There was discussion of using funding offered by the sheriff from his budget and combining that with the funds budgeted to support individual recreation groups. But there wasn't enough to avoid committing some of the general fund's reserves to match the other \$150,000 contributions.

Riddick predicted, based on conversations he's had with private donors, that the county's full commitment would result in donations rolling in.

"I don't think that next year you're going to have to ask for the 150. I'll just throw that out. I won't mention names of the people that have called me that have pretty much said this. They're going to make this happen," he said. "Everybody will see buy in. Is the county going to buy in with the city and really make this work? And I truly feel like, if we do again, within six months, you'll see people coming forward and putting money in and make the recreation go so that next year, I won't even have to ask for a 150 from the city or the county."

Dougherty had previously suggested commissioners each donate \$5,000 from their board salaries to support recreation, and he said he is still willing to do so.

"Commissioner, I understand what you're trying to do, and I fully support recreation, but I also support that we're watching the money that we're spending and where we're pulling that money from because we have so many other issues," he said.

If they continue to add new expenses, Dougherty said they will never be able to roll back the property tax rate.

The consensus was to move forward by funding recreation, with \$135,000 from reserves and the \$15,000 budgeted for outside recreation groups.

Fair management tackled in budget discussions

Now that it owns the fairgrounds, Bradford County is adding up the cost of management and maintenance until the fairgrounds is paying for itself.

As of the county's budget workshop last week, money to insure the buildings — \$22,000 — was already added to the county's budget. Public works was still surveying the fairgrounds to develop a list of needed repairs or upgrades. They needed to be planned for as a part of the county's capital improvement plan.

"As of right now, Rick and Chris in our maintenance department have been down

there doing some inspection," Public Works Director Jason Dodds told the board. "There's been some HVAC issues that they've taken care of. That's the initial shock right now, but we still need to go through that a little closer to see exactly the age of everything down there, and I can give you all an update at the next meeting."

Clerk of Court Denny Thompson said a big unknown is the cost maintaining the fairgrounds. Brad Thomas, vice president of the Bradford County Agricultural Fair, said they are looking at costs such as insurance and utilities. They receive rental revenue from the church that meets there to help cover those costs, but events will be the real source of income for

management and maintenance. They are discussing several events, including the fair in March.

Answering Thompson, Thomas said the fair board intends to be self-sufficient.

"With that being said, it may take, it may take two years to get there," said Thomas. It may be next year before they can take over the insurance bill, and a little longer before the board can be contributing toward the salary of a fair manager.

Not knowing some of the figures such as the anticipated salary of the fair manager complicated predicting self-sufficiency. That person will be key to bringing in revenue.

"We have full-time jobs. It's going to take somebody beating

the bushes and dragging stuff in to get an income. That's not only what the fairgrounds needs, that's what the county needs. We need somebody to bring income in, so it pays for itself," Thomas said.

While his office is handling administration for now, County Manager Scott Kornegay said a full-time manager for the fair needs to be part of the discussion. "Nothing's going to fall through the crack, but the point is, we don't have the capacity to go out and do what Brad's talking about, which is what needs to be done," he said.

Thomas suggested a salary range of \$75,000 to \$90,000 to attract the right person and motivate them to work hard. This was the consensus of the

county commission as well. The county manager and fair board executives will work together on drafting a job description and hiring the fair manager.

"Mr. Scott said it best. You're looking for a unicorn, and we know that, but with the right people on the board to hire, I believe, with the right salary, you're going to get somebody that wants to come in here and really work hard for it," Thomas said.

The fair board understands this is their burden, he added, not the county's burden.

"But we ask the county to help us get to the point where we can handle that burden on our own," he said. When that happens, they may even be able to pay back some of the county's

contribution, he said.

For now, funding from the county reserves will be used to pay the fair manager's salary.

Asked by Commissioner Diane Andrews, Kornegay said there was less than \$5,000 in the fair board account when the county acquired the fairgrounds. More money may be found pending the outcome of an ongoing state-level investigation into actions taken by the prior fair board.

One thing the fair board does have among its members is a lot of experience, Thomas said. They are also motivated to create income through fundraising. But without someone to manage operation of the fairgrounds, it will be difficult to fully understand its position or plan for its future.

Most local funding requests survive veto

Of the millions of dollars allocated locally, only the Arc of Bradford County's request for funding was excluded the state's new budget.

Last week, Gov. Ron DeSantis signed the 2025-26 state budget totaling \$117.4 billion after \$567 million in line-item vetoes. One of those vetoes was \$300,000 legislators had set aside for capital outlay and operations at the Arc.

Other local requests were funded at least in part, including the first year of funding for Lake Butler's new elementary school and Starke's water and wastewater expansion project.

Rep. Chuck Brannan released lists of all the funds budgeted for the area, many of which were personal member appropriation projects he supported in the House and Sen. Jennifer Bradley supported in the Senate. The projects reflect strong legislative support for critical community investments in areas such as infrastructure, education and public safety, he said.

In Bradford County, the funding included:

—Bradford County Sheriff's Office (salary increases for fiscally constrained counties) - \$858,176.

—RJE Building Modernization - \$900,119.

—SLERS Radio Equipment Replacement and Upgrade - \$907,000.

—Courthouse Renovation - \$500,000.

—Keystone Heights Airport - S.R. 100 Road Connectivity - \$744,588.

—Starke U.S. 301 Utility Extension - \$2,000,000.

—School Readiness Services - \$1,317,353.

—Voluntary Prekindergarten Program - \$582,878.

—Preliminary Engineering Consultants Transportation Work Program - \$1,012,279.

—Resurfacing Transportation Work Program - \$7,522,409.

—Small County Resurface Assistance Program - \$2,300,000.

—Prepping Institutions,

Programs, Employers, and Learners through Incentives for Nursing Education (PIPELINE) Fund Workforce Education - \$550,920.

—Public Schools Workforce Education Program Funds - \$1,223,046.

The county is already considering how to best and most efficiently spend the funds. For example, while only 50% of the request for the access road

at the airport was funded, the county will finish design work and utilize the road department for construction. Similarly, the clerk's office and court will collaborate on the use of funds for the courthouse.

In Union County, the funding included:

—Union Lake Butler Elementary School Phase I - \$29,519,032. (Upon completion, in total, this will be an \$88,577,096 project.)

—Union County Sheriff's Office (salary increases for fiscally constrained counties) - \$454,552.

Restoration - \$850,000.

—School Readiness Services - \$622,799.

—Voluntary Prekindergarten Program - \$290,201.

—Public Schools Workforce

Education Program Funds - \$114,402.

You should always do what you believe is right and strive to do it to the best of your ability. Zombie makeup: The scary, beautiful story

Zombies typically invoke fear and disgust, but the story that unfolded at the Bradford County Library’s makeup and special effects class definitely had a surprise ending.

The class was another featured event in the library’s summer series, taught by Jay Woodley, makeup artist from shows like “The Walking Dead,” “Stranger Things” and the film “Peter Rabbit.” Woodley, a Jacksonville native, says he loves having these demonstrations at local libraries because it’s his way to give back.

Woodley knows what it’s like to be a kid with a big dream. What began as a \$20 box of ambition and makeup from Party City, has grown into a unique and storied career. At the young age of five, Woodley saw the old classic “Creature from the Black Lagoon,” and while it scared him, his uncle, who was also a makeup artist said, “It’s just a costume.” That quieted his fears but sparked his interest and desire to go into the special effects industry.

During the class, attendees were not only informed about the history of special effects makeup, which dates to 3,000 BC, they were also taught some improv and zombie walking moves. Multiple volunteers were used for illustration of types of makeup. The crowd was asked for storyline ideas to go with the chosen

“injury” that Woodley was going to create. Multiple “victims” went from healthy to infected in just a few minutes in Woodley’s hands.

Woodley’s creativity is not limited to applying makeup to create zombies; he also has invented his own unique blend of “magic blood powder” and makes his own molds, which he used in the demonstration. They range from nasty cuts to ripped off jaws, he then applies the makeup and “magic blood” splatter to make it look real, even in person.

As Woodley applied makeup in the class, he inspired with his own story of perseverance. He said he was so determined to be

on “The Walking Dead” he auditioned 30 times. He became an extra, then moved from the makeup department to the stunt department. He said he got to be used in everything.

He said his very first paid job was doing special effects makeup for a local boutique in Jacksonville’s zombie party. He laughed and said it’s some of the worst work he’s ever done, but he keeps the pictures to remind him where he came from and how much he’s accomplished. His business all started with that \$20 shoe box of cheap makeup he took to Zombie Walk in Jacksonville. He charged \$2 a piece the first year, \$5 the second year and his work began speaking for itself and he eventually charged \$75.

He credits his success to “years of just not giving up and throwing his name out anywhere people would listen.” His experience even includes a childhood dream of being “friends with Indiana Jones” at Walt Disney World’s Hollywood Studios. He said during his first performance in the live action show, as the giant boulder rolled towards him, he was so excited and it all felt so surreal that he missed a mark and fell and busted his nose, but the show went on and he worked in that role for two years.

He’s been working as a makeup and special effects artist since he was 17, but professionally for 15 years. He said some of

the best advice he received was from a mentor in the film special effects industry who told him, “Kid, never bet your bank on one project. Just go do your job, be the best you can be at it and maybe something cool will happen.” He said, “So far, a lot of cool stuff has happened.”

As the class wrapped up, those who came were entertained, educated and some left a little bloodied, but the most beneficial lesson of the course was to work hard at something you love and maybe you will see your own dreams come to life.

Tom Jenkins won 6th place for Best in Show. He displayed a 1925 Oldsmobile Model S.

"A hundred years old," he said of the gold-colored classic. "The cab is all original, but the fenders and running boards are not original."

Jenkins said a friend discovered the car in a Lake City body shop.

"(The owner) had been working on it for 30-some years," he said, "and the body shop (owner) said I'm not working on it anymore."

Jenkins said he modified the 100-year-old car into a hot rod.

"You can ride it 80, 90 miles per hour down the interstate all day long."

Jenkins said he put in a 94 Z-28 drive train in it.

A search of Jones's person yielded negative results. Ehrnreiter wrote that Jones then consented to a search of his vehicle.

"While at the driver's side, I observed several small white square pieces on the ground near the driver's door," the detective reported. "Upon closer inspection, and based on my training and experience, I identified the substance as suspected crack cocaine."

"When questioned about the suspected crack cocaine," Ehrnreiter continued, "Keith inquired about its location and then attempted to step on the evidence. As he did so, I grabbed his left arm to prevent him from destroying the evidence."

The detective wrote that Jones then fell to the ground, "and I observed that some of the suspected crack cocaine had been destroyed."

Ehrnreiter added that Jones later admitted to Detective Flynn he tried to destroy the crack because his wife was unaware of his use.

Ran out of gas, stole car

Lewis added that as the defendant approached an exit with a shopping cart, the loss prevention officer stopped him, and Taylor ran out a door.

Palatka police later identified the man as Taylor, adding that officers in Palatka stopped Taylor while he was attempting to steal from a Walmart there.

Lewis added that when she first arrived at the retailer, she saw Taylor and a woman together in the parking lot. The woman was later seen on video attempting to get a refund on merchandise for which she could not prove she had purchased.

"(The Starke loss prevention

officer) also stated that this is not the first time Taylor and the unknown female came into Walmart together, taken items or returned a large number of items together," Lewis reported. "Both individuals were not able to be caught in previous incidents."

The 42-year-old was arrested in Starke after Clay deputies transferred the defendant from the Green Cove Springs jail.

According to an arrest report, Clay deputies booked Taylor on March 9 after a loss prevention officer at an Orange Park Walmart observed the defendant on video, taking two Invicta watches out of their boxes and slipping the timepieces into his pockets.

Edwin Vickery, 40, of Starke, was arrested by Bradford deputies on July 3 for withholding support.

D'endra Wallace, 32, of Gainesville, was arrested by Bradford deputies on June 28 for possession of marijuana, possession of dangerous drugs, and a weapons offense.

Arrested for avoiding sex offender laws

Randall Winger, 65, of Lawtey, was arrested by Bradford deputies on July 3 for sex offender violations.

According to a sworn complaint, a deputy investigating claims that the defendant was not living at his registered address, discovered Winger's vehicle parked at a Sapp Street address in Starke for an extended period.

Deputy Antonio Velazquez wrote that he requested Putnam County deputies check the defendant's registered address in the Hawthorne area.

"In response," Valazquez reported, "PCSO deputies attempted an in-person contact at Randall Winger's registered address...Deputies observed that Winger was not present at the residence."

Two days later, Putnam deputies returned to the Hawthorne address and were unable to locate the defendant.

"This request was made due to the continued presence of Winger's vehicle at...W. Sapp Street, Starke, which is not a registered address and where he has previously been explicitly instructed not to reside."

The deputy noted that Winger's past actions demonstrate a pattern of

exploiting the state's sexual offender tracking system.

"It should be noted," wrote Velazquez in the complaint, "that Randall Winger is known for attempting to manipulate the registration system, and multiple investigations have previously been conducted regarding his failure to provide accurate registration information. His actions demonstrate an ongoing and deliberate effort to circumvent Florida's sexual offender registration laws."

Union

Slapped household member

Alexia Staffieri, 18, of Lake Butler, was arrested by Union deputies on June 30 for battery.

According to an arrest report, a witness told deputies Staffieri and a household member were involved in a verbal disagreement when the defendant slapped the victim on the left side of the victim's face.

"I made contact with Alexia, who also corroborated (the witness's) story," wrote Deputy Eli C. Rogers in the arrest report. "(The witness) was also advised that this incident would be reported to DCF."

Mikah Wilson, 20, of Keystone Heights, was arrested by Union deputies on July 2 for possession of child pornography, promoting the sexual performance of a child, and lewd and lascivious battery committed on a child under 16 years of age.

Lori Waters, 62, of Lake Butler, was arrested by Union deputies on July 5 for possession of a controlled substance without a prescription and possession of drug equipment.

Brandon Croft, 41, of Lake City, was arrested by Union deputies on July 6 for vehicle theft.

Clay

Interfered with investigation

Andrew Ables, 26, of Keystone Heights, was arrested by Clay deputies on June 30 for resisting

an officer without violence.

Deputy Brandon Draughon-Miller wrote in an arrest report that while investigating a battery case, he asked a female witness in the McRae area if she would talk to him about an incident that occurred earlier that night.

Although the woman agreed to speak with the deputy, Ables, who was nearby, interrupted the interview and screamed at the officer, stating the woman had the right not to incriminate herself.

"(The woman) spoke up that she would be willing to speak to CCSO," the deputy reported. "Andrew spoke over (her) stating that nothing happened and they weren't involved. Andrew then placed his arms out to his side, preventing (the woman) from stepping forward when she attempted to do so."

Draughon-Miller wrote that both he and the woman tried to calm Ables down, with the woman telling him, "Let me talk to them, it's okay".

However, the defendant refused to back down, and he placed his hands on the woman's shoulders to escort her back inside a nearby house.

"I then ordered Andrew to stop interfering with my investigation multiple times as (the woman) had declared that she is willing and wanting to speak with us despite his protests," wrote the officer. "Andrew then opened the door to the residence, moved (the woman) inside, slammed the door shut, and declared that she will not be allowed to incriminate herself and he will not let her outside the residence to speak with CCSO."

Draughon-Miller wrote that he then patted down Ables for weapons and placed him in the back of a patrol vehicle.

The deputy added that once he completed his investigation, he drove Ables to the Clay County Jail for booking.

Face down in a ditch

Scott Ballou, 37, of Keystone Heights, was arrested by Clay deputies on July 3 for possession of drug equipment, disorderly intoxication, and resisting an officer without violence.

Deputy William A. Stockling wrote in an arrest report that the defendant was observed at a Lake Geneva BP station, walking back

and forth inside the store, arguing with shoppers, and attempting to enter vehicles in the parking lot by pulling on their door handles.

"Dispatch later reported that the defendant was laying face down in a ditch next to the business," Stockling wrote.

The deputy reported that when he met with Ballou, the defendant was slurring his words, unable to maintain his balance, had dilated pupils, and emitted a strong odor of alcohol.

The officer added that when searching Ballou, he discovered four glass pipes in the defendant's pockets, and he zeroed in on one.

"Based on my training and experience," he wrote, "I immediately recognized this item as drug paraphernalia, as the burnt ends and presence of Brillo are consistent with the illicit use of narcotics. I also located two additional clear glass pipes, both containing burnt residue. The fourth pipe was a clear glass pipe with a bulb-shaped end, but it did not contain any visible burnt residue."

Tackled child in thrift store

Adam Henslee, 40, of Keystone Heights, was arrested by Clay deputies on July 3 for child abuse without great bodily harm.

According to an arrest report, the victim told deputies the defendant grabbed him by his torso and tackled him to the ground in a Keystone Heights thrift store.

Deputy Brian Bolena wrote in the report that he observed lacerations on the victim's right knee, forehead, and right shoulder, in addition to light scratches on his right shoulder. First responders evaluated the victim's lacerations but did not transport him to a hospital.

Bolena reported that when he interviewed Henslee, the 40-year-old appeared intoxicated.

"During the interview, it was apparent the defendant was under the influence of alcohol," the deputy wrote. "He exhibited slurred speech, had difficulty maintaining his balance, and appeared disheveled and unkempt, with a strong odor of alcohol emitting from his person."

Former BHS players return to host a meet-and-greet

Two former Bradford High School football players participated in a meet-and-greet at Beef O'Brady's in Starke on July 3 and are eagerly looking toward the 2025 college-football season — a season they hope sees them become contributors on the field as redshirt freshmen.

East Carolina University defensive lineman Torin Brazell and Purdue University defensive back Chail Cummings, who are both 2024 BHS graduates, were available to pose for photos and hand out autographed photos of themselves at the Beef O'Brady's event. Both players have a partnership with Beef's, with the local restaurant offering a signature meal named after each player.

The first year of college football was tough for Brazell and Cummings, with both battling through injuries and having to adjust to not being major players on the field. However, they both still have four years of eligibility remaining. Cummings did appear in five games last year at the University of Memphis, but one was a bowl game, so he didn't exceed the four-game regular-season maximum that would've prevented him from having a redshirt year.

Regarding his decision to transfer from Memphis to Purdue, Cummings said, "I just felt it was the best decision for me to make — play in a bigger league and make bigger and

better plays. That was really it for me. Once I saw the opportunity, I just took it."

Cummings said he also likes the level of competition Purdue plays. Purdue, which is a member of the Big 10 Conference (Memphis plays in the American Athletic Conference), is scheduled to play four teams that finished in the top 20 in the College Football Playoff Rankings and the AP poll. Defending national champion Ohio State and national runner-up Notre Dame are both on the schedule.

It's not just a new start for Cummings. Purdue has a new head coach in Barry Odom.

Another new face on the Purdue staff is Defensive Backs Coach Charles Clark, who, like Cummings, was at Memphis.

In his year at Memphis,


Monique Cardenas had 10 points, while the following just missed scoring in double digits: Jill Gnann and Elise Moore with nine each and Lori Glenn with eight.

Keystone advanced to the Region 2 semifinals, getting 23





Cummings said he learned how to "grind through the week" and be ready to play on Saturday.

He also had to adjust to a higher level of play coming out of high school.

"People are just stronger and faster (in college)," Cummings said.

Still, he didn't view it as too big of an adjustment because he was simply continuing to play a sport that's been a part of his life growing up.

"At the end of the day, it's the game of football," Cummings said.

Cummings said some of his goals for 2025 are to be named a Freshman All-American and to help Purdue win a championship. He added that the hurdles he faced in 2024 will only make him better moving forward.

"Minor setbacks lead to major comebacks," Cummings said.

Brazell, who said his college career "started off a little bumpy" with an injury, found the college game to be 10 times faster than what he was used to in high school. However, a player has to adapt or get left behind. Brazell said it's all about competing and being self-motivated.

"There's no feeling sorry for yourself," Brazell said. "It's always on to the next play."

At East Carolina, Brazell has been practicing against an offense that operates at a high tempo — a tempo he describes as two times faster than normal college speed.

"It's helped me become better," Brazell said. "Regular opponents won't be as fast as what I face in practice every day."

With a year of learning the playbook, working on his quickness and take-off from the line of scrimmage, and gaining weight and muscle, Brazell feels he's put himself in good position to have an impact in 2025.

"I'm just trying to get on the field, get a couple of snaps in," Brazell said.

One thing he's ready to do is terrorize opposing quarterbacks. It's something he hasn't done since December 2023 as a BHS player.

"It's been a minute," Brazell said. "I miss hitting quarterbacks."

Like Cummings, Brazell is also a part of something new, even though he hasn't changed schools. East Carolina named former Defensive Coordinator Blake Harrell as its head coach. Harrell was the interim head coach after Mike Houston was fired after six games into the 2024 season. After a 3-3 start under Houston, the Pirates went 5-2 under Harrell, including a 26-21 Military Bowl win over N.C. State.

In his senior season at BHS, Brazell led the state in Class 2S in sacks with 17, which also ranked him 20th in the state regardless of classification. He had the fourth-most number of tackles for BHS with 62, which included 31 behind the line of scrimmage.

Cummings was Bradford's third-leading tackler his senior season with 83. He had three interceptions and one fumble recovery.



group of more than 70 children packed many activities into one day during a July 3 event at the Gov. Charley E. Johns Conference Center in Starke. Edrick Hamilton, as part of his

12G mentoring program, offers an annual I Am STEM camp in Starke at the Starke Church of God by Faith Community Center. The camp, though, has always been about more than just science, technology, engineering and mathematics. Time is also devoted to children learning such skills as CPR and applying tourniquets from Bradford Fire Rescue and UF Health personnel.

This year, Hamilton collaborated with Caring and Sharing Learning School in Gainesville, which is also hosting an I Am STEM camp.

That school brought some of its children to Starke for Hamilton's event, which he moved to the conference center to accommodate the larger group.

It's all about reaching as many children as possible, Hamilton said, adding that he wants to reach out to other groups in the future so that the event can grow every year.

Besides learning some life-saving skills, including how to use an automatic external defibrillator, children got up-close looks at fire and rescue vehicles and the equipment they contain.

The event also included a demonstration by Bradford County Sheriff's Office Deputy Hiram Gonzalez and his K-9 partner, Waldo, and a program presented by Bradford Family Dentistry hygienists Shawna Burkhalter and Traci Waters.

"I'm just trying to provide them with as much knowledge as I can, especially during the summer," Hamilton said, adding, "You don't know what seed that's sown is going to grow."

Some of those seeds could grow and have a huge impact in the future.

"A kid may not be strong enough to perform (CPR)," Hamilton said, "but they can teach an adult how to do it. That's how a life can be saved."

This year's I Am STEM camp in Starke began with approximately 10 children, but Hamilton said five to six more were expected to start attending the camp the week of July 7. He noted that the financial requirement seemed to be a hindrance to some families, but donations toward the program have enabled some families to send their children.

The camp, which is Monday-Friday for children in second-eighth grades, began June 16 and runs through July 25.

getting 20 points each from Dykes and Moore in claiming the Region 2 championship with an 87-54 win.

Also scoring in double figures were Teague with 17 points, Cardenas with 14 and Gnann with 11.

Moore added 12 rebounds to her totals.

In the state semifinals, the Indians clung to a 12-8 lead over Bishop Verot after the first quarter. They then outscored the Vikings 27-11 in the second quarter en route to a 70-53 win.

Moore scored 22 points and grabbed 11 rebounds, while Cardenas had 14 points and 13 rebounds.

Dykes had 10 points to go along with seven assists and five steals.

Glenn fell two points shy of scoring in double figures and had four assists.

It was a matchup of teams that alternated between number one and number two in the state throughout the season in the championship game, with Keystone coming out on top of Tampa Academy of the Holy Names by a score of 67-55.

Keystone led by seven points after the first quarter, but was

held to six points in the second, resulting in a lead of just 29-28 at halftime.

Dykes, who finished with 15 points and five assists, sank two three-pointers in the third quarter to help the Indians take a 51-38 lead.

Holy Names cut its deficit to eight points in the fourth quarter, but Keystone quickly increased the margin again, with points from Cardenas, Dykes and Glenn making the score 60-43.

Cardenas finished with 16 points, 13 rebounds and four assists, while Teague and Moore had 14 and 13 points, respectively. Teague also had six assists, while Moore added eight rebounds.

Kim Tuller added four points, while Glenn and Gnann had three and two, respectively.

It was the Indians' 14th straight win and capped a 30-4 season.

KHHS is baseball runner-up in 1995

Keystone's Eric Potter and North Florida Christian's John Bentley put together outstanding efforts on the mound, but it was Bentley who threw a shutout as the Indians fell 2-0 in the 1995 Class 3A baseball state-championship game.

The Indians faced a tough task in the first round of that season's

District 4 tournament, having to play University Christian — the top-ranked team in the state — but Keystone got a complete-game three-hitter from pitcher Brett Allen, who struck out five in a 2-0 win.

Keystone trailed Pierson Taylor 4-1 in its next district-tournament game, but scored five runs in the sixth to win 6-4.

The Indians entered the regional playoffs off a 7-5 loss to Trinity Christian in the district-championship game.

In the first round of regionals, the Indians scored a run on Andy Hall's two-out single in the top of the seventh for a 7-6 win over P.K. Yonge.

Keystone scored the game's first six runs, including three in the fifth. P.K. Yonge scored six in the bottom of the fifth to even it up at 6-6.

With two outs in the seventh, Justin Dean was hit by a pitch (the sixth Keystone batter overall to get hit). He scored on Hall's single.

Hall and Bryan Sands went 2-for-4 and 2-for-3, respectively, with Hall driving in three total runs.

Keystone got a huge play from its defense late in the game when Matt Dykes caught a fly ball in right field and threw a runner out at home plate.

Keystone then won the Region

II championship with an 8-1 win over Trinity Christian.

Trinity tied the game with an unearned run in the third, but the Indians scored five in the fourth. Dean, the leadoff batter reached on a wild pitch on a third strike. Dykes was hit by a pitch one out later. Dean and Dykes then attempted a double steal. The Trinity catcher's throw to third sailed into left field. The ball went through the left fielder's legs, allowing Dean and Dykes to both score.

After the next two batters walked, Tony Stevens hit an RBI single, while Allen drove in a run on a ground out. A Potter single drove in the fifth run of the inning.

Potter was the winning pitcher, giving up six and striking out six in a complete game.

Keystone was the only public school to advance to the Final Four. The Indians got an RBI single from Stevens in the eighth inning to defeat John Carroll 2-1 in a state-semifinal game.

The Indians fell behind 1-0 before scoring two in the fourth. Bryan Sands singled and scored on an error, while Dean, who reached on an error, scored on Hall's squeeze bunt.

Dykes led off the bottom of the eighth by reaching on an error. He moved to second on an Allen sacrifice before scoring on

Stevens' single into center field.

In the championship game against North Florida Christian, Potter gave up six hits and one walk in a complete-game effort that ultimately resulted in his only loss of the season.

North Florida Christian's Bently, who would go on to pitch for FSU, allowed three hits and struck out nine.

The Indians, with two outs in the sixth, had two runners in scoring position: Brian Gentry, who reached on a walk, and Potter, who reached on an error. Dean was batting and had taken a second strike to work the count full. He stepped back to take a breath, with the result being that the umpire called a third strike for him being out of the box. The Florida High School Athletic Association had instituted the rule — a batter earns a strike when stepping out of the box without calling timeout — that season.

Keystone finished the season with a 28-8 record.

The Indians would play for the state championship in 1996 as well. Keystone was again the only public school to advance to the Final Four in Class 3A. The Indians defeated Pope John Paul II 14-5 in the semifinals before losing 7-5 to Tampa Catholic in the championship game, bringing an end to another 28-8 season.
